## SCHOLARSHIP CRITERIA BY COUNTRY

**Indonesia:** Sarjana (S1) four-year course with a GPA of at least 3.5/4.

**Malaysia:** A Bachelor degree awarded by a recognised Malaysian university with Class 1 or a CGPA of 3.5/4.

**Taiwan:** A Bachelor degree from a recognised National or Private university with a grade of 80% or GPA 3.5/4.

**Thailand:** A Bachelor degree from a recognised Thai university with minimum GPA of 3.4/4 - 3.6/4. Entry requirements will vary depending on the Institution attended.

**Vietnam:** A Bachelor degree (Bang tot nghiep dai hoc) from a recognised Vietnamese university with a minimum score of 8.0/10 or 80%.

## TO QUALIFY, YOU MUST MEET THE FOLLOWING CRITERIA:

You must be a resident of either Indonesia, Malaysia, Taiwan, Thailand, or Vietnam.

- Applicants must meet country specific criteria, as shown opposite (for above countries) to be eligible for these awards. These criteria are in no way connected to any conditions detailed in the academic offer received from Queen's University Belfast, which must be met to gain entry to the University. Excludes applicants to MBA programme.
- Students must hold an offer for a place on a full-time postgraduate taught programme (excludes MBA) at the Queen's Management School, starting in the academic year 2021/22

and prior to commencement of study have met any academic and language conditions attached to their offer as stated in their offer letter.
