Explore our range of scholarship opportunities available to new international applicants studying at Charles Sturt Sydney or Melbourne campuses.

Vice-Chancellor International Excellence Scholarship

Successful applicants will receive 50% tuition fee reduction throughout the entire duration of the course

Who can apply:

- Outstanding students who demonstrate Charles Sturt values and community contributions. Evidence of community involvement and desire to be involved in the Charles Sturt community will be required upon application (500-word essay minimum)
- Applicants must have an academic entry score of 80% or higher
- Students with unconditional offer or who have accepted their offer to study

Applications close: Applications are open for 2025 intake and close at 11.59pm 15th November 2024.

International Student Merit Scholarship

Successful applicants will receive 30% tuition fee reduction throughout the entire duration of the course

Who can apply:

- Undergraduate students with grades of 75% or above in their Year 12 or equivalent studies
- Postgraduate students with grades of 65% or above in their undergraduate studies
- All new international students who apply to study a degree within 12 months after successful completion of an Australian university AQF level 7 or above degree are eligible to receive the International Student Merit Scholarship.

Applications close: Applications are open for 2024 and 2025*.

Melbourne Launch Scholarship

Successful applicants will receive 25% tuition fee reduction throughout the entire duration of the course

Who can apply:

- All international students commencing in Melbourne in Semester 1, 2025

Applications close: Applications are open in 2024–25 until further notice.

International Student Support Scholarship

Successful applicants will receive 15% tuition fee reduction throughout the entire duration of the course

Who can apply:

- New international applicants studying on-campus in Sydney or Melbourne

Applications close: Applications are open for 2024 and 2025*.

International Joint Cooperation Program

Successful applicants will receive 25% tuition fee reduction throughout the entire duration of the course

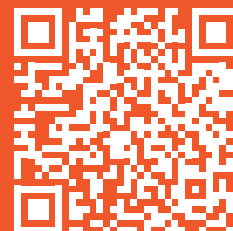
