CAS PROCESS CHANGE UPDATE

Starting in mid-July, students will now be entered into CAS Shield as soon as their application becomes Conditional. This brings our process in line with the approach taken by most other universities that use CAS Shield.

The aim of this change is to give students earlier access to important information about the CAS Shield process and allow them to begin setting up their CAS Shield profiles sooner.
