



Kaplan Merit Scholarship

The scholarship is offered to senior high school graduates who have achieved academic success in their national high school exam results, with the aim to support their undergraduate studies with Kaplan Higher Education Academy (KHEA) in Singapore.

This scholarship covers only the programme fees for the Kaplan Diploma in Professional Business English, full-time Kaplan Foundation Diploma, and the full-time Kaplan Diploma programmes.

To apply for the scholarship, the applicant must submit an essay of not more than 300 words, together with their application for the Kaplan Merit Scholarship 2026. The applicant may choose one of the following topics for the essay submission:

1. What unique qualities of a Kaplan Higher Education Academy education attracted you to apply, and how do you believe these qualities will support your academic and personal growth?
2. Artificial Intelligence is transforming the job market. As a prospective Kaplan Higher Education Academy student, how would you prepare for these changes and position yourself for future career success?
3. As a future member of the Kaplan Higher Education Academy community, how would you help build a sense of belonging for yourself and other students?

Value

- Covers only 50% of the programme fees (exclusive of GST) for the Kaplan Diploma in Professional Business English, Kaplan Foundation Diploma, and the full-time Kaplan Diploma programmes.
- The scholarship awardee will need to bear all other fees and expenses such as their daily expenses, application fees, international student management fees, books as well as supplementary examination fees or re-module/revision fees for supplementary examinations, should the subject require these to pass the Kaplan Diploma in Professional Business English, Kaplan Foundation Diploma, or the Kaplan Diploma programme.

Schedule of Payment, Duration and Other Conditions

- The remaining 50% of the programme fee is payable for the Kaplan Diploma in Professional Business English, Kaplan Foundation Diploma, and the full-time Kaplan Diploma programme.

- Upon completion of the Kaplan Diploma in Professional Business English, and/or Kaplan Foundation Diploma, and/or Diploma programmes, the awardee must continue to pursue their Bachelor's Degree programme with one of the KHEA university partners. The tuition fee must be paid in accordance with the year of enrolment. Should the awardee decide against pursuing their Bachelor's Degree at Kaplan, he/she will have to make full payment of the programme fees for the Diploma in Professional Business English, and/or Kaplan Foundation Diploma, and/or Diploma programme previously completed at Kaplan within a month from receipt of the relevant programme's final exam result. No transfer or refund is allowed for any reason during the course of the Bachelor's Degree programme, save under the conditions stated in the Student Contract. Otherwise, the awardee will have to make full payment of the programme fees for the Diploma in Professional Business English, and/or Kaplan Foundation Diploma, and/or Diploma programme previously completed at Kaplan within a month.
- During the awardee's duration of studies with Kaplan, he/she must achieve a student attendance rate of more than 90%. Should the awardee fail to do so, Kaplan reserves the right to cancel the scholarship with immediate effect and/or seek full payment of the programme fees for the Kaplan Diploma in Professional Business English, and/or Kaplan Foundation Diploma, and/or Diploma programme that the awardee is currently pursuing.
- All international students must adhere to the standard application procedures for enrolment with KHEA. This process includes awaiting the letter of offer issued by KHEA as well as the Student's Pass issued by the Immigration and Checkpoints Authority (ICA) of Singapore. Awardees must meet the requirements set by both KHEA and ICA.
- During each stage of the programme, Kaplan staff will assist in guiding the scholarship awardee to prepare application documents needed to complete the Student's Pass application. Should the Student's Pass application be rejected by ICA for any particular reason, the scholarship will be cancelled accordingly.
- The awardee will not be allowed to transfer or drop out of school during their Kaplan Diploma in Professional Business English, Kaplan Foundation Diploma, and Diploma programme duration. Otherwise, the scholarship will be cancelled with immediate effect and the awardee will have to make full payment of the programme fees for the Diploma in Professional Business English, and/or Kaplan Foundation Diploma, and/or Diploma programme within a month from receipt of the relevant programme's final exam result.
- In the event the awardee does not continue with the Bachelor's Degree programme at Kaplan; transfers or drops out of school during the Kaplan Diploma in Professional Business English, Kaplan Foundation Diploma, and Diploma programme, the awardee's academic certificates and transcripts will be withheld till such time he/she has made full payment of the Diploma in

Professional Business English, and/or Kaplan Foundation Diploma and/or Diploma programme.

- Kaplan reserves the right to withdraw and/or revoke the scholarship if the student breaches or is subsequently found to have breached any applicable law, does not exemplify conduct or performance (whether academic or others) of a deserving student and/or any disciplinary action is taken against the student.
